

READ THESE INSTRUCTIONS CAREFULLY

If your ticket is marked (X) "COURT APPEARANCE REQUIRED":

You are required to come to court on the date, time and place noted on the front side, bottom half of the ticket in the "Court Place/Date" section. However, if you want to plead "NOT GUILTY", complete the form entitled "Avoid Multiple Court Appearances" on the top half, of the back side of the blue copy.

If your ticket is marked (X) "NO COURT APPEARANCE REQUIRED" you have the following two (2) options:

1. If you wish to plead "GUILTY", complete the form entitled "PLEA OF GUILTY AND WAIVER" on the bottom half, of the back side, of the blue copy of the ticket. Follow the instructions on that form and mail it with full payment of fine and costs. The amount of fine and costs are noted below.

Fines and Costs

The fine and costs where court appearances are not required are:

- (a) \$75.00 for all complaints, except (b) and (c) below;
- (b) \$55.00 for seat belt violations cited under 625 ILCS 5/12-603.1;
- (c) \$95.00 for speeding more than 20 mph but not more than 30 mph over the limit.

NOTE: Payment must be by cash, money order, certified check, bank draft, or traveler's check unless otherwise authorized by the clerk of the court. (DO NOT SEND CASH IN THE MAIL; use cash only if paying in person.)

2. If you wish to plead "NOT GUILTY", complete the form entitled "Avoid Multiple Court Appearances" on the top half, of the back side, of the blue copy and follow those instructions.

BOND INFORMATION - FAILURE TO APPEAR

The type of bond you posted is marked on the front side of the ticket in the "Bond" section. The result of your failure to appear or pay this ticket is determined by the bond type identified below and whether your ticket is marked "Court Appearance Required" or "No Court Appearance Required."

1. CASH:

A. FULL CASH BOND:

1. **No Court Appearance Required:** A judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below.
2. **Court Appearance Required:** A judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below. Or instead, a judgment may be entered for the FULL amount of the bond, and/or the court may issue a warrant for your arrest. Any cash deposited will be applied toward the judgment.

B. **10% CASH BOND:** A judgment may be entered for the FULL amount of the bond and/or the court may issue a warrant for your arrest. Any cash deposited will be applied toward the judgment.

2. **ILLINOIS DRIVERS LICENSE:** A judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below. Or, instead, your driving privileges may be suspended, and/or the court may issue a warrant for your arrest.

3. BOND CARD:

1. **No Court Appearance Required:** A judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below. Your card will be sent to the issuing company for payment.
2. **Court Appearance Required:** A judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below. The card will be sent to the issuing company for payment. Or, instead, a judgment may be entered for the FULL amount of the bond, and/or the court may issue a warrant for your arrest.

4. **BOND DEPOSITED IN TICKET NO.** (see front side for number): The bond which has been posted in another ticket also covers this ticket.

5. **NO BOND:** You were unable to post bond with the arresting officer at the time this ticket was issued.

6. **NOTICE TO APPEAR:** A judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below. Or, instead, the court may issue a warrant for your arrest.

7. **PROMISE TO COMPLY** (out of state drivers only): A notice of suspension of your driving privileges will be sent to your licensing state; Or, a judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below; Or, the court may issue a warrant for your arrest.

8. **INDIVIDUAL BOND:** A judgment may be entered against you for fine, penalties, and costs as provided in the NOTICE below. Or, instead, judgment may be entered for the FULL amount of the bond and/or the court may issue a warrant for your arrest.

NOTICE

OF CONSENT FOR ENTRY OF JUDGMENT

If a driver's license, cash bail, bond certificate, or an individual bond was posted or if you were released on a Notice to Appear or Promise to Comply and you were charged with an offense which does not require a court appearance, YOU ARE HEREBY NOTIFIED THAT:

In the event you fail to appear in court or answer the charge on the date set for your court appearance, or any date to which the case is continued, or you do not submit a written plea of guilty to the clerk at least (3) days before that date, you thereby consent to the entry of a judgment of conviction against you in the amount of the applicable fine, penalties, and costs. The cash bail or other security deposited will be used to pay the fine, penalties, and costs. If you are an Illinois Driver and you fail to pay in full any judgments imposed, a notice will be sent to the Secretary of State and your driver's license will not be renewed, reissued, or reclassified, until full payment is received.

AVOID MULTIPLE COURT APPEARANCES

If you intend to plead **NOT GUILTY** to the ticket:

1. Complete this form and mail at least TEN (10) work days before the date set for your court appearance noted on the bottom half of the front side of this ticket (Court Place/Date section).
2. Indicate what kind of trial you want—mark only one box, complete the address section below and follow the mailing instructions in number 3 below.

A new appearance date will be set and you will be notified of the time and date of trial. **Do not come to the court until you are notified.** When you are notified, you should come to court prepared for trial and bring any witnesses you may have.

3. Mail this form to the Clerk of the Court, Traffic Section, at the address noted in the "Court Place/Date" section on the bottom half of the front side of this ticket.

GUILTY PLEA

If you intend to plead **GUILTY** to the ticket and No Court Appearance is Required:

1. Complete this form.
2. Mail this form, together with the fines and costs to the Clerk of the Court, Traffic Section, at the address noted in the "Court Place/Date" section on the bottom half of the front side of this ticket. You must mail this completed form, with all fines and costs, **no earlier than ten (10) work days** after the ticket was issued (noted on the top half of the front side of the ticket), **and no later than three (3) work days** before the court appearance date (noted on the bottom half of the front side of the ticket in the "Court Place/Date" section).

FINES AND COSTS

The fine and costs where court appearances are not required are:

- (a) \$75.00 for all complaints, except (b) and (c) below;
- (b) \$55.00 for seat belt violations cited under 625 ILCS 5/12-603.1;
- (c) \$95.00 for speeding more than 20 mph but not more than 30 mph over the limit.

NOTE: Payment must be by cash, money order, certified check, bank draft, or traveler's check unless otherwise authorized by the clerk of the court. (DO NOT SEND CASH IN THE MAIL; use cash only if paying in person.)

PLEA OF GUILTY AND WAIVER
